Pursuant to provisions of the Constitution of Kenya 2010, the County Government Act 2012, the Public Finance Management Act 2012 and Makueni County Public Participation Policy, 2021, the Government of Makueni County notifies the members of the public, local development organizations, civil society organizations, professionals and other stakeholders about the elections of 3rd Cycle of development committees as follows;

The Qualifications for any person to be elected or nominated to the Development Committee should be;

- A resident of the specific election area;
- Must be passionate and available to serve the community;
- Demonstrate leadership qualities including and not limited to championing development, community mobilization;
- Demonstrate understanding of the County Government's agenda as captured in the manifesto and the CIDP III; and
- Must be of unquestionable character and person of high integrity.

Minimum requirements for a Community Resource Persons shall be;

- A resident of the specific election area;
- Must be passionate and available to serve the community;
- Demonstrate leadership qualities including and not limited to championing development, community mobilization;

- d) Demonstrate understanding of the County Government's agenda as captured in the manifesto and the CIDP III; and
- e) Must be of unquestionable character and person of high integrity.
- f) Be able to demonstrate professional skills;
- g) Be a skilled communicator; and
- h) Be a grassroots mobilizer and a community organizer.

Disqualification from being a Development Committee Member.

- a) state or public officer;
- b) non-resident of that specific election area;
- c) unsound mind;
- d) convicted of an offence whose sentence of imprisonment is of at least six months;

Term Limit

The development committee shall serve for a period of three (3) years which may be renewable for an extra term.

Mode of Election

1. The mode of election shall be through an integrated approach of a secret ballot and nomination of special categories for purposes of inclusion.
2. The balloting process provides for special elective seats reserved **for PwDs and FBOs** for inclusivity from the cluster to the county.
3. Additionally, from ward to county level there will seats reserved for representation of professional groups, local development partners and civil society organizations. These shall be nominated by the groups for appointment by the CEC member incharge of devolution. The nominating organizations or groups shall be required to provide proof a meeting held to nominate their representatives.
