1.0 Introduction

Public participation is a constitutional requirement in county governance. Article 1 of the Constitution of Kenya, 2010, states that sovereign power belongs to the people. In Article 10 (2) (a) and the Fourth Schedule Part 2 (14) of the Constitution, public participation is stipulated as a function of the County Government. Article 174 underscores the need for public participation in governance at the county level, promoting democracy and accountability. Section 115 (1) and Section 87 of the County Government Act No. 17 of 2012 further mandate citizen participation in county processes and outline the principles of citizen participation in counties. Section 184 (1) (c) of the Urban Areas and Cities Act, 2012 (amended 2019) provides for participation by residents in the governance of urban areas and cities.

Public participation allows the people to contribute their inputs and voices to county decisions, resulting in sustainable development.

2.0 Rationale for Preparation of the County Annual Development Plan(CADP)

The Constitution of Kenya, 2010 established a devolved system of governance, comprising a national government and 47 county governments, each with distinct and shared responsibilities as outlined in Article 186 and the Fourth Schedule of the constitution. Among the responsibilities of county governments, as specified in the Fourth Schedule, is county planning and development. The County Government Act, 2012, particularly Section 104, mandates that county governments must engage in planning, and stipulates that public funds shall not be spend outside an established planning framework. These county plans are developed by the county executive and must receive approval from the county assembly. Section 107 of the County Government Act specifies various types of county plans, including County Spatial Plans, Sector Plans, County Integrated Development Plans (CIDPs), and Cities and Urban Areas Plans. To implement the CIDP, the Public Finance Management Act (PFMA), 2012, in Section 126, requires county governments to draft Annual Development Plans (ADPs). The ADP serves as a foundation for implementing the CIDP, directing the allocation of resources to priority projects and programs. According to Section 126 of the PFMA 2012, county governments must prepare a development plan in line with Article 220(2) of the Constitution, which should be submitted to the County Assembly for approval by 1st September each year. The CADP serves as a critical link between the development priorities outlined in the CIDP and the county's annual budget. Additionally, Section 105 mandates that the county planning unit ensure alignment between county plans and the national planning framework. Consequently, the CADP provides a mechanism for aligning county development priorities with Kenya Vision 2030, its Medium-Term Plan IV, and the Kenya Kwanza's Bottom-Up Economic Transformation Agenda (BETA). The

purpose of preparing the 2025-2026 Annual Development Plan is to establish the county planning framework and roadmap for guiding development efforts during the financial year 2025/2026, with the overarching goal of advancing the county's transformation agenda and improving the quality of life for the citizens of Makueni.

3.0 Objectives of the CADP 2025/26 Public Participation Forums

The main objectives of the public participation on ADP were to;

- To identify and prioritize programs and projects for implementation in the FY 2025/26 based on CIDP II, iDEP and subsequent budget public participation that have not yet been funded.
- To provide feedback on community concerns related to county governance and development.

4.0 Public Participation Process and Methodology

The CADP participatory process began with the issuance of a circular by the Executive Committee Member for Finance and Socio-Economic Planning, providing instructions and timelines to all County Accounting Officers.

The County Government conducted public participation forums in 30 wards from 13th to 15th August, 2024 to identify potential projects for implementation in the forthcoming financial year.

The forums were facilitated by technical officers from the County Treasury and the Department of Devolution and Municipalities. We targeted the general public, professionals, opinion leaders, citizen fora members, Ward HODs, organized groups, minority and marginalized groups, and special interest groups. The facilitation methodologies used during the public participation forums included lectures, personal views sharing, group discussion, questions and answers, and submission of memoranda to co.planning@makueni.go.ke.
